## FRONTLINE HEALTHCARE LEADERSHIP SCHOLARSHIP ELIGIBILITY CRITERIA

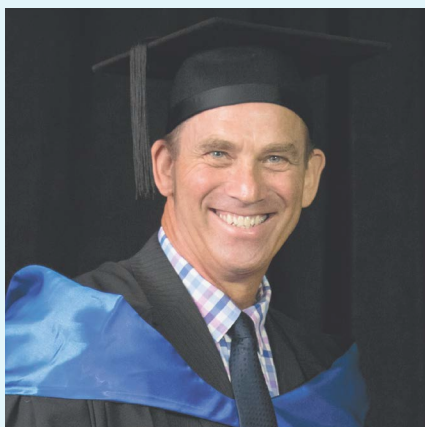
To be eligible for the **Frontline Healthcare Leadership Scholarship**, you must:
