## SELECTION PROCESS

- Kaplan Business School will review each application.
- On the recommendation of a Selection Committee, scholarships will be awarded each trimester to a limited number of students who have demonstrated that they meet the selection criteria to the satisfaction of Kaplan Business School. The decision of the Kaplan Business School Committee will be final.
- Scholarships are only awarded to students who meet the Eligibility Criteria:
  1. eligible nationalities: Brunei, Cambodia, Indonesia, Japan, Korea, Laos, Malaysia, Myanmar, Philippines, Singapore, Thailand and Vietnam
  2. Demonstrate exceptional academic success;
    - a. Postgraduate applicant: 80% average grade from any university in their home country (or their latest UG study).
    - b. Undergraduate applicant: 95% average grade from their home country (or their latest high school completion)
- This award will be applied based on the listed course fee for the relevant year.
- Kaplan Business School reserves the right to offer awards, scholarships or promotions at its sole discretion.
