SECTION

01 APPLICATION

1. Can you recognise my previous study and/or work experience?

Yes.

For domestic and international students, the entry requirements are:

- A Bachelor's degree OR
- An Advanced Diploma/ Associate Degree plus evidence of a minimum of two year's relevant industry experience.

If a student does meet the above academic requirements, they may be offered entry if they demonstrate recognised prior learning (refer to **Recognition of Prior Learning Policy**) such as higher education results, vocational qualifications and work experience.

International students will have their overseas qualification assessed by the Department of Home Affairs and will also have to meet English language requirements.

2. What type of management experience do I need to apply?

If you have a recognised bachelor's degree, then management experience is not required for entry into the MBA, however, the program is best suited for those with several years of business experience as the program assumes a certain level of established business acumen. Students who apply may already be in leadership positions and are looking to advance into executive level roles.

As stated in the answer for Question 1 above, if you have an advanced Diploma

or Associate Degree, then you will be required to provide evidence of at least two years of relevant industry experience.

This means detailing how each learning outcome of the MBA program has been acquired during your work life.





3. What are the minimum English entry requirements for MBA?

Students will need an Academic IELTS score of 6.0, with no less than 6.0 for Speaking and Writing and 5.5 for Listening and Reading for entry into our MBA. Evidence from other English language proficiency tests can be accepted. For the full list of approved tests, please look at our **English Entry Requirements**.

4. Is there a maximum study gap acceptable for MBA?

There are no study gap restrictions. However, there are genuine student (GS) restrictions placed on some regions and countries by the Department of Home Affairs when assessing visa applications. Please contact your agent for more details.

5. What MBA Scholarships are available?

In our genuine desire to help individuals reach their educational and career goals, we offer several scholarships to students in Australia and across the globe.

HIGH ACHIEVERS SCHOLARSHIP

This scholarship nurtures our future business leaders. Australian and international students who can display a record of commendable academic merit in business, or a related field of study, can apply.

Global leadership starts with you! We offer a variety of scholarships to students from various regions, including Australia, who display a record of commendable academic merit.

DOMESTIC STUDENT SCHOLARSHIP

Awarded to selected Australian students who can display a record of outstanding academic merit.

KARNKANTHI INDIGENOUS EDUCATION PROGRAM

Kaplan Business School has signed an agreement with the University of Adelaide's Wirrtu Yarlur Aboriginal

Education unit to offer scholarships to Indigenous and Torres Strait Islander students across Australia in the Karnkanthi Indigenous Education program.

FRONTLINE HEALTHCARE LEADERSHIP SCHOLARSHIP

This scholarship aims to encourage health workers to augment their skills to cope with the healthcare leadership required during an unprecedented time.

SCHOLARSHIP FOR ASYLUM SEEKERS

Kaplan Business School makes five scholarships available per year to asylum seekers, for any undergraduate or postgraduate course, one for each campus equal to 100% of the tuition fees for the full duration of the course.

6. Can I do an MBA without a business-related degree?

Yes. Your bachelor's degree does not need to be business related for entry into the MBA.

7. When do you accept applications for the MBA program?

Kaplan Business School has 3 trimesters in a year. The earliest you can apply for a trimester is one year in advance. Refer to our **application dates**.

8. Do I need an agent to apply? Can I apply through any agent?

You do not need to apply through an agent. You can apply directly to KBS. However, an agent is familiar with the school application and migration process and can answer any questions you may have about the course or moving overseas. We advise all students outside of Australia to apply via a **registered KBS agency**.

SECTION

02 PROGRAM

1. How long does it take to complete an MBA at KBS?

A full-time MBA degree will generally span over six trimesters, or (on average) two years. You can choose to complete a general MBA, an MBA specialisation or an MBA dual specialisation. An accelerated study option is available depending on subject offerings.





2. What are the benefits of a double specialisation?

Our dual specialisation option, MBA (Two Specialisations), gives you the flexibility to graduate with knowledge and skills in two different but complementary focus areas, without having to complete any extra subjects.

The key benefits of studying two specialisations include:

1. Versatility

With market trends constantly changing, having two specialisations can give you the strategic advantage to pursue one or the other field depending on the state of the industry and growth opportunities.

2. Wider networks

Pursuing two specialisations gives you

access to a wider range of internships and work opportunities to help build your professional network.

3. Gain entrepreneurship skills

An entrepreneur needs to be able to understand several aspects of business operations which can be gained through two complementary specialisations (e.g. entrepreneurship and project management, entrepreneurship and digital management).

4. Career changes

Having two specialisations is useful if you have worked in one industry and decide you want to make a career change.

You can choose two from the following MBA specialisations. At least one of the two MBA specialisations must be either:

- Health Services Management
- Project Management or
- Tourism and Hospitality Leadership

(all 3 are offered face-to-face only)

All other MBA specialisations will be delivered online only:

- Digital Management
- Entrepreneurship
- Women in Leadership
- International Leadership
- Data-driven Leadership

3. Can I package the MBA with a Postgraduate Qualifying Program (PQP) or Graduate Certificate?

Yes, you can. If you do not meet the requirements for the MBA, you can first enrol in a PQP (4 months) and then after completing a Graduate Certificate (8 months) you will be eligible to complete the remainder of your MBA.

4. Can I study English before starting my MBA?

Yes, you can. KBS offers a range of English language programs for students who need to improve their English proficiency before commencing their studies with us. For more information, please visit **Kaplan English Australia**.





5. What's the difference between an MBA and a master's degree in business?

Both an MBA and Master's in business or management are advanced business degrees that professionals study to advance their career.

An MBA focuses on high level business leadership and managerial skills. They cover a wider range of topics such as management, financing and strategy and there are opportunities to specialise in areas such as business analytics or accounting. An MBA program assumes a certain level of established business acumen, so it is best suited for those who already have several years of business experience, are in leadership positions or looking to advance into executive level roles.

A Master's in business usually focuses on one specific area of business such as Marketing. Best suited for those coming from a bachelor's program or with a few years of professional experience looking to make a career change.

6. What is the MBA timetable like? How many days/hours of study per week?

A full-time study load for an MBA student is two subjects per trimester.

- 12 weeks per trimester
- 2 subjects per week
- Each subject has a 3hr live class (on campus or online)
- Each subject requires 14 hours per week.

7. Can I study the MBA completely online?

If you are a domestic student, you can complete our MBA completely online. However, if you are an international student, online study limits do apply. For more information, please visit immi.homeaffairs.gov.au/.

14. What is the MBA Capstone subject?

In the last trimester of your MBA, you work on a capstone subject called Strategy. It is designed to consolidate your learning by applying key areas of learning into a real-life project that you create and choose. The feedback and expert input you receive from your lecturer can help you replicate your project in your career.

1. What professional experiences are open to MBA students?
